- Final numbers must be notified no later than two weeks prior to the function. These numbers will be used for billing purposes. Balance must be paid in one transaction.
- Minimum spend Monday - Thursday \$5,000 | Minimum spend Friday - Sunday \$8500
- Maximum 150 guests
- Public Holidays incur additional surcharge
- Pricing subject to change.
- Above packages for private functions only (excluding weddings)
- Security is at the discretion of the venue but responsibility of the client.
- All dietary requirements **MUST** be advised with final numbers.

#### DAMAGES
